### For an Unattended Funeral service, the following terms apply: -

- Full Payment is required at the point of arrangement.
- No discount or early settlement offer.

### For an Attended Funeral Service, and all other funeral related services, excluding memorialisation, the following terms apply: -

- All disbursement (3<sup>rd</sup> Party) charges and 15% of our professional service fees must be paid in full and in advance of the funeral being conducted. We reserve the right to postpone the funeral until such charges are paid in full. Payment must be made at least 48 hours in advance of the funeral date.
- We reserve the right to request full payment of the written estimate, regardless of the type of funeral selected, under certain circumstances.
- Full Payment of goods and/or services provided, are due within 28 days of us providing you with a valid invoice.
- We may charge interest on the overdue amount at the rate of 10% a year above the base lending rate of the Bank of England from time to time. This interest shall accrue daily from the due date until the date of actual payment of the overdue amount, whether before or after judgment.
